IN CONSIDERATION OF THE ACCEPTANCE OF MY MEMBERSHIP, I HEREBY FREELY AGREE TO AND MAKE THE FOLLOWING CONTRACTUAL REPRESENTATIONS AND AGREEMENTS.

I understand that serious accidents occur during bicycle riding, training and racing and that participants in bicycle riding, training and racing risk sustaining mortal or serious personal injuries and property damage as a consequence thereof. Knowing the risks of bicycle riding, training and racing, I hereby agree to assume those risks, and to release and hold harmless all persons or entities mentioned below.

I hereby waive, release and discharge for myself, my heirs, executors, administrators, legal representatives, assigns and successors in interest (hereinafter collectively "successors") any and all rights and claims, including but not limited to claims for negligence, which I have or which may hereafter accrue to me against the officers and members of Velo Allegro, for any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with bicycle riding, training and racing.

I agree it is my sole responsibility to be familiar with the ride courses, USCF and Velo Allegro Club Rules and all rules pertaining to riding on public roads. I accept responsibility for the condition and adequacy of my bike and equipment. I will ride wearing a helmet that satisfies the requirements of the USCF Racing Rules and that can protect against serious head injury, and assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which, to my knowledge, would endanger myself or others if I participate in a club event, or would interfere with my ability to participate in any club events.

I agree, for myself and successors, that the above representations are contractually binding, and are not mere recitals, and that should I and/or my successors assert any claim in contravention of this agreement, I and/or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending such claims. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any subsequent waiver or modification. This agreement supersedes, modifies and takes the place of any prior Velo Allegro "Membership Release".
